

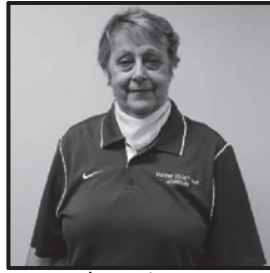

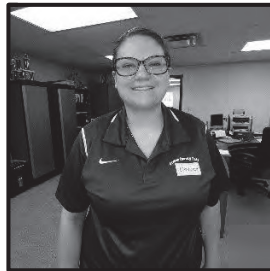

Membership (\$30.00), fill out a petition as well as securing 13 valid signatures from other Greene Co. Ag. Members with a 2018 membership ticket. Petitions must be turned into the fair office no later than July 17, 2018, at 4:00 p.m.

**Any petitions received after that will NOT be accepted
Article VIII- Becoming a Board Member**

Anyone interested in becoming a Director of the Greene County Agricultural Society must be a member in good standing for at least 3 of the last 7 years; and/or being an active committee member of the Greene County Fair Auxiliary Committee. In addition, this person must attend at least 2 meetings within the past 12 months prior to the year he/she wishes to take out a petition to become a Board Member.
